NOTICE INTIVING TENDER

On behalf of Nagaland University, sealed composite tenders are invited from eligible and registered Class-I Contractors of NPWD/ CPWD having valid contractors license accompanied by a tender fee (Non-refundable) as specified below through Nagaland University challan pledged in favour of Registrar, Kohima Campus, Nagaland University for the following works. The tenders will be received upto **2:00 PM** on **27-02-09** (to be dropped in the tender box) and will be opened on the same day at **3:00 PM** or as maybe specified in the presence of the contractors or the authorized representatives, if any, or as may be notified.

NOTE: -

1. Details and particulars of tender documents can be obtained from the office of the Executive Engineer, Nagaland University, Kohima on payment of cost of of tender document (Non-refundable) as specified through University challan with effect from 16-02-09 till 20-02-09. Tender documents shall be issued to eligible applicants on 24-02-09 after 12:00 noon. The tender shall be received on the next working day, in case the date stipulated for receipt of Tender in this NIT is declared a Holiday/non-working day.
2. Required earnest money in the form of Call Deposit through any Nationalised Bank alongwith Indian Postal Order worth Rs.10/- duly pledged in favour of Registrar, Nagaland University, Kohima campus is to be furnished by the tenderer without which their tender will not be accepted.
3. The prospective tenderer who fulfil the following requirements shall be eligible to apply. Joint ventures are not accepted.
 - i) Should have satisfactorily completed 1(one) similar work costing not less than 80% (Eighty percent) of the estimated amount put to tender or 2(two) such similar works each costing not less than 50% (fifty percent) of the estimated amount put to tender or 3(three) such similar works each costing not less than 40% (Forty percent) of the estimated amount put to tender during the last 3 (three) years, ending last day of the month previous to the one in which the tenders are invited. Similar works means "Construction of RCC framed structure Building including internal and External Electrification and Road, site development and allied works" executed under State Govt./Central Govt./Public Sector undertakings/Autonomous organization".
4. Solvency certificate in favour of the Tenderer of minimum 15% of the amount put to Tender from the Banker of the Tenderer in original should be enclosed, without which the Tender shall be disqualified.

5. The contractor should arrange all the machineries and materials of specified quality by himself from open markets.
6. The Tenderer should quote their rate on flat percentage basis i.e., as per/ above/ below Nagaland PWD 2008 Schedule of Rates.
7. Contractors may inspect the site and source of Construction materials, if required, before casting tender.
8. Contractor should put his/her full name and address in the specified column in the tender document. Tenders of those contractors who give only the initial without giving full name and seal will be rejected.
9. Tenderer should come by himself/herself to purchase the tender documents and in case she/he could not come by himself/herself the tender documents will be sold only to the authorized representative of the Tenderer whose signature is attested by the concerned contractors.
10. Contractor may satisfy himself/ herself that the tender value commensurate with the work orders before execution of work. Complaint in this regard shall not be entertained after work order is issued.
11. Quality control tests during execution of work, as recommended by relevant IS Code and as per direction of Engineer in charge, shall be done by the Contractor at his/her own cost. Besides, one or more original receipts of purchase of Steel, cement etc. (conforming to ISI) from the authorized dealers of such materials are to be submitted to the Engineer-in-charge, if applicable, on procurement of such materials, if asked by the Department.
12. Work Contract Tax shall be deducted at source as per prevalent rate notified by the Govt. of Nagaland from the Bills (Running or Final) of the Contractor.
13. Non Tribal Contractors should furnish "Trading License" issued by the competent authority without which their Tender shall be disqualified.
14. Alterations, corrections, if any, in the Rates quoted by the Tenderer should be initialed by the Tenderer. Usage of "White ink" to erase and then rewrite the Rate should be avoided.
15. The Contractor, on signing an indenture in the form to be specified by the Engineer-in-charge, shall be entitled to be paid during progress of the execution of the work upto 75% of the assessed value of any such materials which are in the opinion of the Engineer-in-charge non-perishable, non-fragile and non-combustible and are in accordance with the contract and which have brought on the site in connection therewith and are adequately stored and / or protected against damage by weather or other causes but which have not at the time advance been incorporated in the works. When materials on account of such advance shall be recovered/ deducted from the next payment made under any of the clause or clauses of this contract.
16. Notwithstanding the various conditions prescribed in the Tender document, the University may relax on or more such conditions, if required, in favour of deserving Tenderer, in the interest of the University, without compromising with the quality and standard so required for implementation of the work.
17. The University reserves the right not necessarily to accept the rate of the lowest tenderer and may reject any or all the tenders without assigning any reason thereof.
18. The University also reserves the right to enhance/decrease the tender value as per the availability of funds.
